

THE TOWNSHIP EMBRACES MOSTLY CUT-OVER LAND, FROM WHICH THE ORIGINAL TIMEER MAS BEEN REMOVED. THE PRESENT GROWTH CONSISTS LANGELY OF BECOMD GROWTH WHITE AND RED PINE, JACK PINE, AND MAPLE ON ITH DIPLAND, WITH CEDAR AND TAMARACK IN THE SMAMPS.
