

THIS PLAT ALSO REPRESENTS THE SURVEY OF AN ISLAND INLLAKE SUPERIOR, IN SEC. 8, WHICH WAS NOT INCLUDED IN THE ORIGINAL SURVEY, NOR SHOWN UPON THE OFFICIAL TOWNSHIP

THE RESURVEY WAS EXECUTED PURSUANT TO AUTHORITY CON-TAINED IN GENERAL LAND OFFICE LETTER 140864 "E" DATED MARCH 4,1931, WHICH BEARS DEPARTMENTAL APPROVAL UNDER DATE OF MARCH 5,1931.

THE TOWNSHIP SUPPORTS A HEAVY STAND OF VIRGIN AND SECOLD GROWTH MAPLE, BEECH, AND BIRCH TIMBER ON THE SHAMPS. UPLAND AREAS, WITH DENSE CEAR AND SPRUCE IN THE SHAMPS.
