IN THEIR TRUE ORIGINAL POSITIONS ACCORDING TO THE BEST AVAILABLE EVIDENCE OF THE POSITION OF THE ORIGINAL CORNERS. ALL DIFFERENCES RETWEEN THE MEASUREMENTS SHOWN ON THE ORIGINAL PLAT AND THOSE DERIVED IN THE RETRACEMENT HAVE BEEN DISTRIBUTED PRO-PORTIONALLY BETWEEN ACCEPTED CORNERS IN ACCORDANCE WITH SURVEYING RULES. REFERENCE WILL BE MADE TO THE ORIGINAL PLAT FOR THE SHOWING OF THE AREAS AND MORE DETAILED DE-SCRIPTIONS OF THE VARIOUS SMALLER SUBDIVISIONS. THE RESURVEY WAS EXECUTED PURSUANT TO AUTHORITY CON-TAINED IN GENERAL LAND OFFICE LETTER 1362538 "E", DATED FEBRUARY 20, 1930, WHICH BEARS DEPARTMENTAL APPROVAL UNDER DATE OF FEBRUARY 24, 1930.
