The purpose of this document is to clearly communicate the current WLD named focus-area information and updated summaries; All those specific "named focus-area" land areas of particular interest to the Michigan DNR Wildlife Division (WLD), are, for ease of communication, termed State Wildlife / Game Areas (SW/GAs or SWGAs), or "Wildlife-Lands", "WLD-lands", WLD Focus-Areas and/or WLD Project Areas. For simplicity, refer to these grouped areas as SW/GAs or WLD-lands.

Notes explaining "area types":

(A.) "Dedicated types" to the DNR Wildlife Division (administration) directly, where "Dedication" is a formal process which approves administering Division, intended purpose for an area, and other details. The list of these areas is not expected to change much or often, as the dedication process is involved and sets-up long term interests for conservation and management of wildlife. These specific types include: State Wildlife Areas (SWA); State Game Areas (SGA); and State Wildlife Research Areas (SWRA). *Note:* the State Fish and Wildlife Area (SFWA) type no longer exists as the one remaining area was rededicated in memorial with name change, and rededicated to a State Wildlife Area.

In **Table 1**, these Dedicated areas are shaded line entries (row back-shaded light green) as those formally Dedicated to WLD by official State process with DNR Director and NRC.

(B.) "dedicated -to-other types" are areas which are WLD focus areas or WLD project areas now or in the past the DNR Wildlife Division has an interest, where WLD is involved with management/ co-management, funding some portion of the area now or in the past, etc. but WLD is not lead on administration. For each area named, officially the land administration is by another DNR Division, another agency like US Fish and Wildlife Service (USFWS), US Forest Service (USFS), County government, or entity as indicated below. Many of these areas exist because of a particular focus for wildlife management, including deer, waterfowl, grouse and more, or a special project funded by Federal Aid, or were created by a specific cooperative agreement. As a group, conceptually these areas are all "State Wildlife Management Areas", but may have other official terms for the area type, as indicated below. For example, Grouse Enhanced Management System (GEMS) areas are GEMS but functionally are SWMAs, as are all those lised in Table 1, part B, below.

Notes on Table 1 -and- Table 2:

CHANGES in WLD-named-focus-areas and acreages, from recent document versions of Tables 1 & 2: Some long-term users of these two tables will notice that there were larger changes (decreases) in 2020 in both number of areas and totals in Table 1 (above) and 2 (below). Therefore, a comment is added in this document in order to maintain confidence in data and that there is no major error causing the differences. These differences from recent previous statistics to now were due to

- (a.) Regular ongoing land acquisitions or land-swaps in existing named areas;
- (b.) Addition of 2 new SGAs (Potterville and Crystal Waters) in 2020 and 2021; and
- (c.) Retirement of some old wildlife management areas (typically openings or floodings, setup by WLD and now either established or served original purpose) after several review of purposes of some wildlife management areas, in the UP and NLP, and if continued reasons for maintaining them as a unique named focus area -or- to retire the named area (focus area outline) and manage the areas as part of the State Land system already being done with WLD involvement; This resulted in retiring named focus areas and change in the comanaged/coooperator lands of WLD-named-focus-areas.

*** **For both Table 1 and Table 2**, there is a newly-added requested column on the far right-side, called "acres of approx. water in this area*** and which lists where appropriate the acres of an area which are water and which are Great Lakes water (implying the area is on Great Lakes shoreline). Values are listed in the format of "[#/#]" or "[A/B]" where number is A total approximated acres of water in the area, and number B is the portion (in acres) of water related to one of the Great Lakes (GL) portion = [(acres water)/ (Great Lakes water only)]. This field which was added a couple years ago, is an attempt to represent that portion of total estimated area acreage which is composed of potential inland water and what is the portion of connected water from one of the the Great Lakes. The water portion were identified using the 2011 USGS NALC landuse/landcover data set intersected with the WLD-lands polygons. The portions identified as water are also known to include significant amounts of submerged and emergent marsh, mudflats and sand/sandbars or are valuable wildlife habitat and conservation areas relevant to WLD, beyond just a polygon boundary acreage total of each area.

Specific notes on Table 1:

** In Table 1: Area names marked with a double-asterisk, are areas (typically comanaged or cooprator areas like SWMAs, etc.) where WLD spent funds or helped setup the area (like a flooding), but the area may not now have active management activities because the original habitat project is working; this may be the case for self-managed floodings, seasonal floodings, or for floodings which have low water levels due to changes in local conditions. Do NOT assume because an area has "flooding" in the name, that it has open water at all times or is always suitable for waterfowl; it may have established marsh and wetlands areas but may not be as wet throughout the year, yet it is functioning on the landscape and still a WLD interest area.

Be aware that some areas previously named or referred to as a "flooding" have (a.) been experiencing low water levels either seasonally or permanently; (b.) may not have actual open water now but have well developed wetland areas; or (c.) the "flooding" portion of the name may only be related to a historical name based on the start of the WLD-project or because of seasonal flooding, and is not a flooding year-round.

Note: regarding area acres: Every reasonable effort has been made to be systematic and accurate. These are <u>approximated</u>, rounded, and may be from GIS but should be very close to official DNR realestate records (LOTS database), plat information, deeds, certified surveys and more, based on official surveys if can (if available), etc. Every effort and due-dillencence is made if can to be as reasonable accurate as can be with current technology and records. Some areas include portions related to State owned bottomlands, some officially deeded but others non-deeded (but State authority is in State Constitution and Michigan Compiled Laws) yet are included because that portion of area is very important to our stewardship activities and public trust roles. Ownership details are complex and every effort is made to provide a fair, logical and consistent representation for these important Dedicated areas and focus-areas. As DNR staff continue to improve our acces to detailed information (like certified surveys and more) there are chances that the small areas of specific individual SW/GAs may change as they are updated to imported data
