#### Comments from stakeholders received prior to Compartment Review

Comment received recognizing the significance of Whitefish Point in many aspects including its migratory habitat corridor, and bird habitat area and seeking clarification on nomination as an official Natural Area designation.

Comment received recognizing the significance of Vermilion Point as an ecologically diverse area with cultural, migratory bird habitat and recreational values. Comment proposes the area be established as an official Natural Area.

Comment received in compartment 42054 suggesting the area should be a "nature preserve" under the basis of the abundance of native animal species present. Comment also requests no clearcutting.

Comment received in compartment 42067 to extend the areas unavailable to harvest from the widewaters to the private property line along the northside of betsy/sheldrake river.

Comment received in compartment 42067 to keep Vermilion Road wild by not clearcutting and preserving road aesthetics.

Comment received in compartment 42054 for stronger enforcement by law enforcement to monitor issues arising from dispersed camping within the area.

## Comments from stakeholders received during Compartment Review

Comment heard during opening public comment period requesting the use of prescribed fire within natural red pine stands in compartments 42054, 42067 and 42094. Specific comment heard during compartment 42054 and 42067 requesting the use of a sequence of prescribed fires in combination with timber harvest.
