B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

15 - W 1/16 Cor. common to Sec. 29 & 32 - No evidence of Consumer's 'T' iron. Set 2" Alum. Cap on 5/8" x 34" rebar per Standard BLM Procedure. Position on E'ly edge of powerline clearing and is deflection point for Consumer's Fee Strip.

14 - S 1/16 Cor. common to Sec. 29 & 30 - Set 2" Alum. Cap on 5/8" x 34" rebar per Standard BLM Procedure.
