9 - CE 1/16 Cor., Sec. 30 - Set stamped 2" Alum. Cap on 5/8" x 48" iron rebar per Standard BLM procedure in swamp. E-W single strand is 3.5' N.

12 - CS 1/16 Cor., Sec. 30 - Set stamped 2" Alum. Cap on 5/8" x 34" iron rebar per Standard BLM procedure. NNW 69' to centerline of Gravel-Sand Rd. NE-SW. S16°W 74' to corner post of single strand S & E.
