B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

B11 - 1/4 Corner common to Sec. 30 & 31 - No GLO evidence found. Set 4" DNR Alum. Cap on 1" x 36" Galv. iron pipe by single proportion to GLO between 'A11' and 'C11'. N-S single strand wire is 27' E. Single strand goes East 82' ± S. DNR Mon. accepted as a careful and faithful reestablishment of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

B11 - 4" DNR Alum. Cap on 1" x 36" galv. iron pipe

Set Blue Carsonite Post 1' SW

S50°W 12.86' to set N & T in SE side 5" R. Pine scribed 'XBT'

S5°E 7.99' to set N & T in W side 5" R. Pine scribed 'XBT'

N27°E 20.12' to set N & T in W side 12" R. Pine scribed 'XBT'

S68°E 34.04' to set N & T in N side 12" R. Pine scribed 'XBT'
