A. Description of original monument and accessories and/or subsequent restoration:
(J8) Center of Section 23. Not established in the original survey.

(16-Sec. 21) East 1/16 corner between Sections 21-28. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(J8) Established the corner at the intersection of straight lines connecting opposite Quarter corners, all of record. The corner established falls 3' East of and 10' South of the intersection of the centerlines of ditches South and West.

(16-Sec. 21) Found and accepted a PK nail with a brass tag midway and on line between Section corner to the east and Quarter corner to the west. Replaced the PK nail with a monument as described below. The corner falls in the centerline of Hwy. M-48.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(J8) Set 1"IDx36" I.pipe with 4" alum.

MDNR cap. Set measuring nails with plastic tags in:
