(5-Sec. 19) North 1/16 corner, Section 19. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(13-Sec. 19) Established the corner at the intersection of straight lines connecting opposite 1/16 corners.

(5-Sec. 19) Established the corner midway and on a straight line between Center of Section 1325.20' South and 1/4 corner 1325.20' North.
