B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

D-5 Found a Standard Kent County Witness Monument 200' ± South of South edge of Toohey Lake, on line of a tree row running South, per L.C.R.C.'s #6775 and #8002 as set by Tom Starr in place of a iron he found which checked a 1972 survey by Moore & Bruggink.
