I, Robert L. Jamros, in a field survey on October 20, 2000,

do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

M08: PLS William A. Burt, DS, 1841. Set quarter section post. Birch 14", S.57°W., 10 links. Spruce 10", N.30°E., 58 links. \*\*\*\*\* No other subsequent restoration of record.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

M08: Established corner position at midpoint and on line between section corners ¼ mile North and South. Found very faint paint lines of timber cruisers North and West from this position. No original G.L.O. evidence was found. Corner position as established is accepted as a careful and faithful reestablishment of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

M08: Set 2½" x 30" Berntsen aluminum monuments no. A1NB30 with ¾" aluminum cap stamped to identify corner position. Established reference trees with BT signs, blazed, scribed and painted. Set PK nails for measure with aluminum I.D. washers in the following: Hemlock 8", N.02°W., 27.58 feet (¼S BT); Hemlock 10", N.67°E., 26.41 feet (¼S BT); Hemlock 11", S.21°E., 19.81 feet (¼S BT); Hemlock 15", S.65°W., 33.14 feet (¼S BT). Survey marker sign on 6 foot steel post, S.65°E., 0.80 feet. All bearings are magnetic.
