A. Description of original monument and accessories and/or subsequent restoration:

E4 - 1/4 Corner common to sections 8 & 9, T30N,R06W

1976 - L.C.R.C. (from DNRE Land Corner File) - Carl F. Roser, P.S.#12028 - Found and accepted 1 1/2" pipe. Set DNR cap on 1" pipe inside same. 1 1/2" pipe was recovered by department in 1961. RLS Bob Findorff also used this corner in 1967.
20" Maple S61°E 60.5'; 9" Maple N65°E 60.2';
8"B. Cherry N21°W 87.8'; Center E-W Co. Rd. Due N. 10'

1977 - MDNR Survey Map - Plan No. R-5-I-I - Carl F. Roser, P.S.#12028 - Same info as above. Show bearings and distances North and West.

B. Description of corner evidence found and/or method applies in restoring or re-establishing corner:

E4 - 1/4 Corner common to sections 8 & 9, T30N,R06W

MDNRE Forester Ken Phillips found 1 1/2" pipe, 24" long with DNR alum cap lying on ground on the South side of E-W Co. road near vicinity of the position of the corner. I reset corner per 1977 MDNR survey map by Carl F. Roser, P.S.#12028, using record bearing and distances from the C 1/4 corner and CE 1/16 corner to E4. Set 5/8"x34" rebar and drove fd. DNR mon. over rebar. Accepted monument as a careful and faithful reestablishment of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

E4 - 1/4 Corner common to sections 8 & 9, T30N,R06W

5/8"x34" rebar inside 1 1/2"x 24" pipe and 4" dia. Alum. DNR cap

Wit: *N60°E 61.03' to set N&T on SE side 24" Sugar Maple
S05°E 46.44' to set N&T on W side 10" Elm
S70°W 32.62' to set N&T on S side 7" Elm
N15°W 31.00' to set N&T on E side 18" Sugar Maple

Set Blue Carsonite Post 1' South
