

I, Stephan J. Szyszkoski, in a field survey on that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey ⁵ instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of 6 a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with 7 the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, 8 re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(5-Sec. 8) North 1/16 corner, Section 8. 1993 - Established by the undersigned midway and on line between N1/4 corner and Center of Section. Set 1"IDx32" I.pipe with 4" alum. MDNR cap. 6" Sugar S71W 19.4', 10" Sugar N67W 29.1', 12" Sugar N26E 28.8', 5" Sugar S62E 30.5'.

(8-Sec. 8) West 1/16 corner, Section 8. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(5-Sec. 8) Found the 1993 monument in good condition and at record bearing and distance from three of the 1993 witnesses. Made one new witness, as described below.

(8-Sec. 8) Established the corner midway and on a straight line between the West 1/4 corner of Section 8 and the Center of Section 8, both monumented and of record.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(5) Fd. 1"ID I.pipe with 4" alum. MDNR cap. Set measuring nail with MDNR tag in the side of: Sugar N65W 29.5' 12" old marks 1993 BT 14" Sugar N28E 29.45' do do 8" Sugar S61E 30.8' do do 4" Sugar S19W 30.7' mrkd "1/16S BT" Set sq'd cedar post adjacent. Bearings are magnetic.

(8) Set 1"IDx32" I.pipe with 4" alum. MDNR cap. Set measuring nail with MDNR tag in the side of: mrkd "1/16S BT"

9" Sugar N14E 11.2' 6" Sugar N68E 20.75'

do 8" Sugar S11W 37.2'

do 10" Sugar S59W 32.95' do

Set sq'd cedar post adjacent. Bearings are magnetic.
