Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

H5 - ¼ corner common to sections 10 & 15, T25N, R14W- Found remains of witness #3. No GLO evidence was found. Dug 3' x 5' area searching for stake remains at N3°W 110 feet from 50" WPS. No evidence of stake was found. Also searched 167' at N3°W but no evidence of monument there either. Sometimes Slawson's distances are in feet but all indications are his dimensions are in links in this area. No evidence of witnesses #1, 2 or 4. Thus set Benzie County Remonumentation monument at N3°W 112.3' from CL. remains of the 50" WPS. About 40' north of here a single strand barbwire to the north on the ground projects south to this position. Measured east 1549' ± 10' (1581'-enter swamp S-SW - GLO) to bottom of bank-edge of swamp. Measured east 1692' ± (1687'- stream 20 S. SW. -GLO) to west edge of stream 15' ± wide- flow south. Measured grid bearing and distance as follows; N87°26'26"W 2647.02' (2642.64'-GLO) to 'G5' and S86°47'37"E 2631.45' (2642.64'-GLO) to 'I-5'. Benzie County monument accepted as the best available evidence of the position of the original corner.

Part C: Field Evidence of Perpetuation or Monumentation of Corner(s)

H5 - Benzie County Remonumentation Monument being a stamped 3" brass cap on a 5/8" iron rod or ¾" iron pipe x 36" long encased in 4" x 36" long concrete cylinder. Set Blue Composite Post 1' North.
 N23°E 12.28' to set nail & tag (N & T) in W. side 18" White Pine scribed 'XBT'
 S42°E 10.85' to set N & T in NE side 7" Sugar Maple scribed 'XBT'
 S55°W 20.20' to set N & T in NW side 5" Sugar Maple scribed 'XBT'
 N64°W 35.72' to set N & T in NE side 17" White Pine scribed 'XBT'
 S3°E 112.30' to set ½" x 18" rebar in CL. 50" White Pine Stump (#3)
