Reestablished corner by single proportionate measurement between Northwest and the state of the st REWA COL corners of Section 27. Set a 1/2" iron with cap L.S. 33142. Witnesses:

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E OVUMET MINIMAN BONDER This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found a 1/2" iron with cap L.S. 33142 and all record bearing trees as called for in the above mentioned 1991 LCRC. Replaced the found iron with a 1/2" rebar and plastic Chippewa County Remonumentation cap.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
