This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found a ½" iron with cap #29251, 3.5'± north of the centerline of an east-west bituminous road. Also found two of the record witness objects as called for the above mentioned 1980 LCRC. Measurements to witnesses and other corners In the area confirm that the found ½" iron occupies the position of the previously described ½" pipe. Replaced the found ½" iron with a ¾" rebar and aluminum Chippewa County cap in a monument box.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Placed a ¾" x 24" rebar with a stamped aluminum Chippewa County Remonumentation cap in a monument box at the corner location, replacing a found ½" iron with cap #29251. Corner falls 3.5'± north of the centerline of 20 Mile Road.
