B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

expressed below:

H-11 (T45N, R1W) This corner is being perpetuated as part of the Chippewa County

Remonumentation Program.

Found a 1" pipe in a monument box in the centerline of Tone Road, west of road to the south, as recorded in liber 8, page 223. Corner is 2666.22 feet from section corner to the west, 2654.31 feet from section corner to the east, and is 16.06 feet south of a straight line between said section corners. This fits very well with a breakdown of Section 27, done by the Department of Witnessed 1" pipe with witness number 1995
