A. Description of original monument and accessories and/or subsequent restoration:

H-11 1/2 Corner Common to Sections 27 & 34, T46N, R7W

1850 - Original corner established by Well Burt, a spruce post. Witnesses: Spruce 6, S651/2°E 12 links - Spruce 8, N31°W 08 links.

Found no evidence of subsequent restoration of this corner.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found a squared cedar post, quite rotted, at the intersection of lines of old steel fence posts to the north and to the east. Found post is 2670.8 feet from section corner I-11 to the east, 2687.2 feet from section corner G-11 to the west, and is 0.7 feet south of a straight line between sald section corners. The GLO notes indicate this corner midway between section corners 2673 feet east and west. Accepted the found post as the best evidence of the original corner location and replaced it with a 3/2" rebar and stamped aluminum Chippewa County Remonumentation cap.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Placed a ¾" x 24" rebar with a stamped aluminum Chippewa County Remonumentation cap at the corner location, replacing a found squared cedar post.
