

I, William L. Karr, in a field survey on December 13, 1999, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.



A. Description of original monument and accessories and/or subsequent restoration:

Witness Corner to Meander Corner common to Sections 15 and 16, Township 47 North, Range 1 East.

James H, Mullett went North between Sections 15 and 16, 51.75 chains to river and set meander post. 1845

F.H. Brown, County Surveyor, re-survey of County Farm field notes field in County Surveyors office. Brown 1889 states that he set a post at meander corner and confirms distance of 51.75 chains as distance of line between sections 15 and 16.

1941 Alford Colwell in certified survey in file cabinet Section 16, Township 47N, Range 1 East County Surveyor's office shows a distance of 451.5 feet on the Section line from the North side of Riverside Drive to the river.

R.H. Larsen sketch dated 1960 in plat book #3 verifies distance of 451.5 feet from North side Riverside Drive to 1960 river on Section line. Identifies concrete monument at point on North side Riverside Drive.

Bancroft W. Bufe map of Dr. Mertaugh's property shows Bufe set two monuments (381.5 feet and 451.5 feet) 1971 from monument found on North side Riverside Drive on extension of Ridge Road to North.

William L. Karr, P.S. 27450 established witness corner to meander corner as part of Hellow Estates Plat recorded at Liber 15, page 24 of Plats and recorded LCRC at Liber 9, page 123 of Chipewwa County Corner

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: Witness Corner to Meander Corner common to Sections 15 and 16, Township 47 North, Range 1 East. This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found no evidence of the original corner. Found a 4" diameter concrete monument with cap no. 27450. Corner is 1063,84 feet North of 1/4 corner Sections 15 and 16. Original notes call for meander corner to be 11.75 chains or 775.50 feet North of said 1/4 Corner.

Original meander location falls in front lawn of house. Accepted corner position as found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: Witness Corner to Meander Corner common to Sections 15 and 16, Township 47 North, Range 1 East. Corner is a 4" diameter concrete monument with a 1/2" iron with P.S. no. 27450 cap. Corner falls more or less eight feet Southwest of top of bank of St. Mary's River.
