

A. Description of original monument and accessories and/or subsequent restoration:

(E-5/E-6) Witness Corner to the Meander Corner Between Sections 16 and 17, T. 47 N., R. 1 W.

- 1845 James H. Mullett set post 21.65 chs North of 1/4 corner.
- 1888 County Surveyor Records, Book #1 page 235 shows distance on West side of section 16 as 3835'.
- 1928 Alford Colwell. Plat of Grand View, point of beginning of plat is at the intersection of section line with the shore of the St. Mary's River, no mention of distance South to 1/4 corner.
- 1961 L.F. Levin, survey in Grand View and Shallows Subdivisions, Plat Book #1, page 24, County Surveyor regards shows the section line at the P.O.B. of Grand View Plat.
- 1984 L.R. Rogers, Certificate of Survey in govt. lot 1, section 17, shows that he recorded the Northeast correction of Survey in govt. lot 1, section 17, shows that he recorded the Northeast correction of Survey in govt.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: (E-5/E-6) Witness Corner to the Meander Corner Between Sections 16 and 17, T, 47 N., R, 1 W

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Considerable erosion has occurred along this part of the river. The 1961 survey by Levin shows the 1905 shoreline 60' North, and the 1845 shoreline 108.4' North of the P.O.B. of Grand View Plat. Could not find the corner shown on the 1984 survey by Rogers.

Re-established the P.O.B. of Grand View Plat from existing subdivision monumentation and accepted the location as the witness corner to the meander corner. The current position falls on the section line, 106.24' South of the original survey location.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (E-5/E-6) Witness Corner to the Meander Corner Between Sections 16 and 17, T. 47 N., R. 1 W.

Corner is a 3/4" x 48" iron with an aluminum Chippewa County Remonumentation cap. The corner falls at the high water mark next to a clump of maples.

Witnesses: 10" White Birch (Easterly of 5) S 82° E 25.09' 10" Spruce S 26° E 7.11' 6" Red Maple (in clump of 3) S 63° W 0.94' 3" Pipe N 69° W 17.17'

Bearings are compass bearings, corrected for declination (7° W), all distances are to a nail and tag in the side of tunless otherwise noted.
