I, Larry R. Rogers, P.S., in a field survey on December 8, 2000, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(B-5) 1/4 Corner common to Sections 7 and 8, Township 47 North, Range 2 East.

John Mullett placed original 1/4 Section post in 1845 and established the following witnesses: 8" Sugar N62W 21 lks and 12" Sugar S58E 30 lks.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(B-5) 1/4 Corner common to Sections 7 and 8, Township 47 North, Range 2 East.

This corner is being perpetuated as part of the Chippewa County Remonumentation Program

Found no evidence of original corner or any subsequent restoration. Used single proportionate measurement to re-establish corner position. Distances to Southeast and Southwest corner of Section measure 2612.87 feet (GLO = 2640 feet)

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(B-5) 1/4 Corner common to Sections 7 and 8, Township 47 North, Range 2 East.

Corner is a 3/4" iron with stamped aluminum Chippewa County Remonumentation cap.

All trees are blazed and painted.
