

Rogers, P.S., in a field survey on December 08, 2000, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and for that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as

- A. Description of original monument and accessories and/or subsequent restoration: (E-3) Section Corner Common to Section 4, 5, 8 and 9, Township 47 North, Range 2 East. The original corner post was placed in 1845 by John Mullett. Corner was re-established prior to 1901 by County Surveyor Stillwell. 1901 and 1919 County Surveyor notes refer to "Stillwell" corner and recite a distance of \$187/5188 along the South line of Section 5.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: (E-3) Section Corner Common to Section 4, 5, 8 and 9, Township 47 North, Range 2 East This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

OVUMEN OVUMEN THE PARTY OF THE PARTY O Found no evidence of original corner or Stillwell corner. Corner position was re-established by double proportionate between the South 1/4 corner of Section 5, the Southeast corner of Section 3, the East 1/4 corner of Section 5 and the East 1/4 corner of Section 8. Distances North and South to 1/4 corners measure 2635.75 feet (GLO = 2640) Distance West to South 1/4 corner of Section 5 measures 2595.1 feet (CS = 2594). Distance to Southeast corner of Section 3 measures 10586.68 feet (GLO = 10581.12 feet)

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (E-3) Section Corner Common to Section 4, 5, 8 and 9, Township 47 North, Range 2 East. Corner is a 3/4" x 48" rebar with plastic Chippewa County Remonumentation Cap in 6" of standing water.
