

I, Larry R. Rogers, P.S., in a field survey on December 01, 2000, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(E-6) 1/4 Corner common to Sections 16 and 17, Township 47 North, Range 2 East. The original corner post was placed in 1845 by John Mullett. 1908 County Surveyor notes show the 1/4 corner 2605 feet from both the Northwest and Southwest corners of Section 16. In 1992, Larry R. Rogers, P.S. 29251 reestablished the 1/4 corner midway between the Northwest and Southwest corners of Section 16 and on the centerline of Townhall Road. A new LCRC was filed in Liber 9 at Page 126 of Chippewa County Corner Records

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner; (E-6) 1/4 Corner common to Sections 16 and 17, Township 47 North, Range 2 East. This corner is being perpetuated as part of the Chippewa County Remonumentation Program

Recovered Rogers' 1/2" capped iron pin 6" below grade and in the centerline of North - South Townhall Road (gravel) and found two previous witnesses intact. Accepted corner position as found and established two new witnesses. Distances to Section corner to North and South measure 2606.5 feet (C.S. = 2605 feet).

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (E-6) 1/4 Corner common to Sections 16 and 17, Township 47 North, Range 2 East.

Corner is a 1/2" x 24" iron pin with P.S. cap #29251 6" below grade and in the centerline of Township Road. Corner falls 5 feet South of a row of small spruce trees to the West.
