I, William L. Karr, P.S., in a field survey on December 08, 2000, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

**A. Description of original monument and accessories and/or subsequent restoration:**

(E-8) 1/4 Corner common to Sections 20 and 21, Township 47 North, Range 2 East.

1845 John Mullett, DS set Post Cedar 10 S69W 16  
Cedar 8 N19E 8

1906 FH Brown, Chippewa County Surveyor shows North 1/2 Mile between 20 and 21 as measuring 2620 and South 1/2 Mile as measuring 2625. He notes corner as original and in place previously, but gone at this point.

1923 FH Brown, Chippewa County Surveyor shows North 1/2 Mile between 20 and 21 as measuring 2607.00 and the South 1/2 mile as measuring 2645.28 feet. He notes that an individual by the name of Clark had done work on the interior of Section 20 that was in error but was reluctant to make changes because of the length of time that lines had been in place.

1927 AH Colwell shows North 1/2 mile between 20 and 21 as measuring 2621.5 which is consistent with Brown's 1906 survey.

**B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:**

(E-8) 1/4 Corner common to Sections 20 and 21, Township 47 North, Range 2 East.

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found no evidence of original corner. Found a very old "T" iron 34.7 feet East of a North - South (right-of-way) fence and on line with a very old fence line to the East. Distance North to Section corner 16, 17, 20 and 21 is 2615.40, (Brown 2620) Distance South to Section corner 20, 21, 28 and 29 is 2616.21 (Brown 2625). Accepted corner position as found and remonumented.

**C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:**

(E-8) 1/4 Corner common to Sections 20 and 21, Township 47 North, Range 2 East.

Set a 3/4" x 24" iron with stamped aluminum Chippewa County Remonumentation Corner Cap flush with ground and 35 feet more or less East of North - South fence and on fence line to the East.
