

 John Mullett set original 1/4 section post in 1845. In 1981, a LCRC was recorded in Liber 5 at Page 074 of the Chippewa County Corner Records by W.L. Karr, P.S. 27450 and describes the corner as a found 1" pipe 2 feet above grade with the following witnesses: 10" Aspen N61E 34.92 feet; power pole (SU1/2781/1) S18E 31.84 feet and a power pole S77W 87.08 feet.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

 (I-4) 1/4 Corner common to Sections 10 and 11, Township 47 North, Range 2 East.

 This corner is being perpetuated as part of the Chippewa County Remonumentation Program

This corner is being perpetuated as part of the Chippewa County Recovered 1" pipe and two power pole ties as previously recorded. Accepted corner as found and established two new witness trees.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(1-4) 1/4 Corner common to Sections 10 and 11, Township 47 North, Range 2 East.
