B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 1/2" x 18" rerod in monument box in centerline of T-road South. Excavated and found no other evidence. Found all 1973 witnesses and two 1990 witnesses. Measured South 2725.95 (Recorded 2725.94) to L-2, T19N, R3W, per (132) 1-431. Measured East 2628.49 to M-13. Measured West 2669.44 to K-13. Fence line to North. Measured East 80 ft. to stream (GLO 165 ft.). GLO topo notes appear to be in error, i.e. stream does not fall in swamp and is well defined with high banks on both sides. Arnold Lake Road underwent major reconstruction in the 1990's. Old Corners destroyed during construction were to be perpetuated by Wilcox, County Engineer.
