Replaced maple stake with monument described below. Notes by B. D. Buckler, R.L.S., indicate he set a 1" iron pipe with 4" brass cap from the W. Pine BT. Pipe now missing, but Buckler may have only witnessed the corner position on 11-20-1957, intending to come back at another time to install the pipe, but never actually did, as it does not appear as though one had ever been in the ground. Monument described below was set from Buckler's NBT's. Buckler's W. Birch is now 9" dia., his R. Oak 14", and the aspen dead.
