

Drahn in a field survey on <u>September 25</u>, 19 97 do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

Corner established by Austen Burt on July 9, 1851. Original B.T.s --- 12" Sugar N.27 E. 13 Links (8.58') --- 14" Y. Birch N.09 W. 23 links (15.18') --- Corner position lays 11.21 chains (739.86') NW of Mile Corner No. 2½.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Restored corner position at record bearing and distance from the remains of the two original B.T.s. The first is a large deep stump hole with pieces of decayed Sugar Maple wood; the second one is now a 24-30" decayed Yellow Birch stump. The 3.38 chains north to "Y. Birch 20") now a very large Yellow Birch stump decayed to well below ground line; the 11.95 chains north to "Y. Birch 8") now a decayed 18-24" Yellow Birch stump and the 11.21 chains SE to Mile Corner No. 2½ are all in accordance with the field notes of the original Government Survey.
