I, Richard L. Drahn in a field survey on May 5, 1999 do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

Corner established by John Burt on 8/6/1847. Original B.T.s --- Sugar 16" S.71 E. 12 links (7.92') --- Spruce 24" N.45 W. 26 links (17.16') --- Sugar 18" N.60 E. 52 links (34.32') ---

Corner position restored by Richard L. Drahn, RLS 21564 on 8/1/85 by re-tracement measurement to recovered line trees north, south, east & west. Logging road construction has destroyed the original corner and B.T.s. He set a 2" X 30" aluminum pipe with a 3 1/4" stamped aluminum cap and the following new B.T.s: --- 6" Sugar Maple N.24 W. 29.97' --- 6" Sugar Maple

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

S.62 W. 55.59' --- 8" Sugar Maple S.28 E. 31.75' --- 6' Metal sign post S.53 E. 2.26'

Corner recorded in Gogebic County Liber 2, Page 732 on 1/10/86.

Recovered the monument as described and the bearing trees as follows:
