Corner established by A. Merryweather, U.S. Deputy Surveyor, on August 16, 1851. Original bearing trees:
Hemlock 30" N.50W 10 links (6.60 feet)
Lynn 5" S.38E. 11 links (7.26 feet)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
No G.L.O. remains. Re-established corner position on line between and equal distance from the northeast and southeast section corners of Section 17, T.46N., R.42W.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
At the corner position I set a 2 1/2 " diameter by 30" long aluminum monument with a 3 1/4" aluminum cap with magnet stamped to read: T.46N., R.42W.; 1/4; S-16, S-17; 1994; R.L.S. 21564 from which I established the following new blazed and scribed bearing trees and/or objects:
