I, Stephan J. Szyszkoski, in a field survey on 09/29/15 do hereby state  
that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2  
above were in conformance with regulations and rules therefore as required in the current manual of survey  
instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of  
a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with  
the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established,  
re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded  
on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(J13) Standard 1/4 corner on the South line of Section 35. 1845 - Established by W.A.Burt, Deputy,  
midway and on the Township line between Section corners 40.00 chains east and west. Set post.  
Tamarack 20" N58°E 33 links, B.Ash 6" N65°W 22 links. 1926 - Notes of P.A.Larson state [referring to  
N1/4 of Section 2 52-35] "B.T. Tam 18" stdg". Note, this is not a common 1/4 corner with Section 2,  
T52N-R35W.

(K12) Quarter corner common to Sections 35-36. 1846 - Established by S.W. Higgins, Deputy, midway  
and on the Section line between Section corners 40.00 chains north and south. Set post. Cedar 10"  
N21°W 11 links, Cedar 12" S05°E 6 links.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(J13) The original post and accessories were not recovered. The OBT Tamarack mentioned in the 1926  
Larson notes was not recovered. There is, in the corner area, a rotted 28" Tamarack stump, no  
markings, but it is located too far west of the record position to suppose that it is the original  
BT, being about 13' west of the position subsequently monumented. Finding no evidence of the  
position of the original corner on the ground, I reestablished the position for the corner midway  
and on the Township line between Section corners 2642.41' east and west.

(K12) The original post and accessories were not recovered. Found no acceptable evidence of the  
position of the original corner on the ground. Reestablished the position for the corner midway  
and on the Section line between Section corners 2596.33 feet north and south. The position falls in  
a swamp.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(J13) Set 1"IDx28" I.pipe with 2" alum. MDNR cap.  
Set measuring nail with MDNR tag in the side of:  
9" Cedar S76°W 22.65' mrkd "1/4S NBT"  
8" Cedar N30°W 17.05' do  
5" Cedar N22°E 6.1' do  
10" Cedar S47°E 18.6' do  
Set sq'd cedar post adjacent.

(K12) Set 1"IDx28" I.pipe with 2" alum. MDNR cap.  
Set measuring nail with MDNR tag in the side of:  
Dead standing 19" Cedar S34°E 33.9' "1/4S NBT"  
4" Balsam S27°W 36.0' do  
Brown Carsonite post North 1.0'  
Sq'd cedar post South 2.0'
