

- A. Description of original monument and accessories and/or subsequent restoration:
- L-5 Quarter corner common to Secs. 12 & 13, T24N,R8E

- B. Description of corner evidence found and/or method applies in restoring or re-establishing corner:
- L-5 Quarter corner common to Secs. 12 & 13, T24N,R8E

Searched area well, but found no evidence of any corner. Searched for possible square cedar stake or State of Michigan monument from 1926 Dept. of Transportation survey. Set 4" stamped aluminum DNR cap on 1"x6" galvanized pipe by single proportionate measurement. Accepted as a careful and faithful reestablishment of the position of the original corner.

- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- L-5 Quarter corner common to Secs. 12 & 13, T24N,R8E

Set 4" stamped alum. DNR cap on 1"x6' galvanized pipe. Wit: N63°E 10.95' to set N&T on NW side 10" Cedar S19°E 10.98' to set N&T on SW side 6" Cedar S45°W 12.77' to set N&T on W side 6" B. Spruce N43°W 28.81' to set N&T on NE side 8" Cedar Set Blue Carsonite Post 1' North
