Part A. Corner History

a. Special Meander Corner on the west (right) bank of the Paint River. The SE corner of Gov't Lot 3, being also the NE corner of Gov't Lot 5, Section 13. Not established in the original survey.

b. Southeast 1/16 corner, Section 14. Not established in the original survey. Found no subsequent record.

Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

a. Established the position for the corner on a straight line between Quarter corner K06 and Center of Section 13 L06, at it's intersection with the ordinary high water mark on the west (right) bank of the Paint River. The position for the corner was not monumented. Established a WITNESS CORNER to the SMC approx. 3.5' west of the OHWM and on the 1/4 line.

b. Found a 2" brass cap, marked "Marathon Corporation" affixed to a 1" ID iron pipe S77°W 1.3' from the intersection of the east and south 1/16 lines of Section 14. Accepted the monument as a careful and faithful determination of the position of the corner.

Part C: Field Evidence of Perpetuation or Monumentation of Corner

a. Set 1"IDx28" I.pipe with 2" alum. MDNR cap.
Set measuring nail with MDNR tag in the side of:
11" Maple N16°W 26.45' mrkd "WC BT"
12" Maple S26°E 44.2' do
6" Balsam S22°W 26.9' do
5" Balsam S85°W 8.25' do
Set sq'd cedar post adjacent.

b. Found 2" brass cap "Marathon Corporation" on a
1" ID iron pipe. Set measuring nail with MDNR tag
in the side of:
9" Sugar N17°E 4.25' mrkd "1/16S BT"
6" Sugar S45°E 16.2' do
5" Sugar S08°W 16.4' do
7" Maple S63°W 9.85' do
Set sq'd cedar post adjacent.
