**A. Description of original monument and accessories and/or subsequent restoration:**

- L7 - GLO - Set 1/4 post - T. Whelpley - 1853  
 W. Pine 20" S 14½°W 21 L.  
 Hem. 12" N 1¼°E 15 L.  
 - Fargo Eng. - 1912 - Fd. Hemlock down with mark sufficient to identify as U.S. Hemlock 12" N 1¼° E 15. Fd. W. Pine Stp. proper distance and nearly same course as noted by U.S. Set iron and crockery corner  
 W. Pine Stp. 30" N 6 ½°E 31 ¾ L.  
 Y. Pine stp. 16" S50°E. 45 ½

**B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:**

- L7 - ¼ Cor. Common to Sec. 13 & 24 - Fd. ¾" x 2.5' long iron pipe w/ hooked end per Fargo lying on ground. Used one GLO and one Fargo BT's to dig for crockery. Fd. 10 pieces of white butter dish crockery. Set 4" DNR Alum. Cap on 1" x 36" galv. iron pipe at found crockery. DNR Mon. accepted as a careful and faithful perpetuation of the position of the original corner.

**C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:**

- L7 - 4" DNR Alum. Cap. on 1" x 36" Galv. iron pipe. Placed found crockery at base of mon. as memorial. Set blue carsonite post 1' N.  
 N 6°E 20.41' to set N & T in face of 32" WPS fd. scribed 'X' (FE)  
 S 10° W 15.86' to set spike in centerline 20" Pine stp. (GLO)  
 S 40° W 8.77' to set N & T in NW side 25" R. Pine scribed 'XBT'  
 N 35° E 45.54' to set N & T in NE side 25" R. Pine scribed 'XBT'  
 N 24° W 17.05' to set spike in W side 26" W. Pine scribed 'XBT'  
 N 69° E 34.32' to set spike in N side 18" W. Pine scribed 'XBT'
