

the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

- A. Description of original monument and accessories and/or subsequent restoration:
- C7 1997 Remonumentation LCRC L.5, P.168 E. D. Farrier, PS #24594 Found 5/8" x 18" rebar. Pulled & set 5/8" x 18" re-rod w/ brass cap in Mon Box 1' West of centerline North Sharon Rd. & centerline Spencer Rd. No GLO witnesses found. The Kalkaska Co. peer group approved and accepted the above monument as the best available evidence of the position of the original corner.
  - 1) set nail & tag N43W Power Pole, 51.95'
  - 2) set nail & tag N45E cut off Power pole, 41.00'
  - 3) set nail & tag S70E 13" Cedar, 124.10'
  - 4) set nail & tag S54W support pole, 54.62'
- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- C7 Corner common to sections 17, 18, 19, & 20, T26N, R6W. Found monument box in approximate centerline intersection. Unable to remove cover. Dug out and removed monument box filled with cold patch, found 3½" Brass cap on 5/8" X 12" rebar under box. Found witnesses #1, #2, & #4, fitting position. Replaced 5/8" X12" rebar with found 3½" brass cap on a 5/8" X 34" rebar. Removed cold patch from monument box and Reset.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- C7 31/4" Brass cap on 5/8" X 34" rebar in monument box

Nail & tag in SW. side power pole (#1) Set blue carsonite post with location tag S45°E 66'
