- A. Description of original monument and accessories and/or subsequent restoration:
- K11 1838 GLO S. Sibley Set Post
 - 1) W. Oak 8" N83°E 36 L.
 - 2) Pine 6" N64°W 32 L.
 - 1908 J. W. Nicholson Survey for highway comm. along N. line of Sec. 35 & 36. Old Govt. corner perpetuated both old witnesses found (blown over) and stake.
 - 3) W. Oak 6" N24½°W 73 L.; 4) W. Oak 4" S27°W 68 L. (Cor. on side hill) S89°36'W 39.61 Ch. to 'J11'; S89°38'E 39.41 Ch. to 'L11'.

- 1973 LCRC L. C002, p. 155 C. F. Roser (PS #12028)
 - Reestablished corner on straight line projection west of East ¼ mile of south line of section as occupied, old fn. and fn. ridge, there being a record of survey for this mile dated 5/08/1908. Corner as reestablished fits a position by dbl. prop. reasonably close. Set DNR monument and Cedar Gd. post. 5) 9" W. Oak S58"W 34.8';
 - 6) 13" W. Oak N60°W 32.9'; 7) 7" Maple N58°E 30.2'
- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- K11 Section Corner common to Sections 25, 26, 35 & 36, T19N, R12W Fd. 4" Dept. of Conservation (DOC) Aluminum Cap on 1" iron pipe per Roser. No GLO evidence was found. Fd. stumps of Roser's witnesses that fit DOC Monument. Searched for evidence of Nicholson BT's but there are not any large hardwood trees or stumps within a reasonable distance. Area appears to have been clear cut within last 15 years and probably not the first time. Based on recovery of Nicholson's positions at 'l-11' and 'J11' a double-over position [per Nicholson's notes 'J11' was set ½ way and on line] would be N8*55'W 52' of the Roser monument. Searched this position but nothing was found. Measured grid bearing and distance of N89°17'32"W 2639.40' (2637.36' GLO, 2614.26' JWN, 2629.8' CFR) to 'J11' and S89°15'30"E 2616.34' (2644.62' GLO, 2601.06' JWN, 2616.5' CFR) to 'L11'. Based on the retracement of the 2 miles of Nicholson's survey along the N. lines of Sections 35 & 36 it appears there is a 1°± error in his bearings somewhere in the survey. His 2 mile distance is short 58'±. The DOC Monument falls on a North facing hillside. Presented this information to the Lake Co. remonumentation peer group on December 17, 2013. The consensus of the group was to accept the Roser DOC monument as the best available evidence of the position of the original corner.

- K11 Stamped 4" DOC Aluminum Cap on 1" galvanized pipe. Set Blue Composite Post 1' North S41°E 26.94' to set Nail & Tag (N & T) in SW side 4" Oak

S41 E 25.94 to set Nall & Tag (N & T) In SVV side 4 Oa S72°E 47.23' to set N & T in N, side 6" W. Oak N22°E 9.88' to set N & T in E, side 2" W. Oak

S22°W 34.75' to set N & T in W. side 3" Oak
