

- E8 1/4 Corner common to Sec. 20 & 21, T19N, R12W Found bent over 4" Dept. of Conservation (DOC) Aluminum Cap on 1" x 3' long iron pipe. No GLO evidence was found. Found both of Roser's witnesses that fit bent over monument. Both witnesses are standing but dead. Centerline of NNW - SSE 2-track is 99'± East. DOC monument accepted as a careful and faithful reestablishment of the position of the original comer.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- E8 Replaced bent over DOC monument with stamped 4" DNR Aluminum Cap on 1" x 3' long galvanized iron pipe.
