A. Description of original monument and accessories and/or subsequent restoration:

(A-9) Section corner common to Sections 19 & 30, Township 43 North, Range 10 West, and Sections 24 & 25, Township 43 North, Range 11 West.

1849 William Ives, D.S. set post Fir 10 S84°W 20
Fir 12 N34°E 25

1986 Neil Hill, P.S. 27447 found no evidence of the original corner or subsequent restoration and used a DNR survey in Section 24, Township 43 North, Range 11 West to reset corner. Set 1/2" iron in monument box and recorded in Liber C, Page 173 of the Mackinac County Corner Records.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(A-9) Section corner common to Sections 19 & 30, Township 43 North, Range 10 West, and Sections 24 & 25, Township 43 North, Range 11 West.

Found 1/2" iron with P.S. cap no. 27447 in monument box and one remaining witness. Accepted corner position as found. Corner was to be destroyed during road reconstruction of U.S. 2. and was rewitnessed prior to construction.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(A-9) Section corner common to Sections 19 & 30, Township 43 North, Range 10 West, and Sections 24 & 25, Township 43 North, Range 11 West.

After road reconstruction set 1/2" iron with 3" stamped aluminum Mackinac County Remonumentation corner cap in monument box. Road stationing MDOT plans dated 7/21/97 is 27+216.79.
