Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

- B6 Center 1/2 corner Sec. 18, T13N, R1W Fd. 1/2" capped iron # 21567 at corner of fences mostly down N, S & W. Fits centerline of Trail road East. Centerline of E-W Drain is 20' South as per County Drain notes. Area is disturbed from oil pipeline construction in the past. Did not find $\frac{3}{4}$ " pipe per Ayres but their witnesses fit within \pm 1' of $\frac{1}{2}$ " CIR # 21567. Condition of witnesses as follows: #1, 2, 5 & 9 are gone; #3 - OK; #4 - Fd. stp. @ 69.5' to centerline; #6 - fd. stp.; #7 - Dead Ash; #8 & 10 are OK. Measured grid bearing and distance as follows: S89°04'18"W 2574.80' (2572.02' - FTG) to 'A6'; N89°09'16"E 2628.89' (2625.48' - FTG) to 'C6' and N0°14'21"E 2625.85' (2623.5' - FTG) to 'B5'. 1/2" CIR # 21567 fit proportionally of Gibbs distances and is accepted as the best available evidence of the position of the corner.
 - Reference Point Found 1/2" capped iron #39074 is S12°52'W 6.87' from 'B6'. This is the apparent position used by Bebee per his Rec. Survey L. 7, p. 649. This position appears to be the intersection of lines from 'B7' to rejected position near 'B5' and line from rejected positions near 'A6' and 'C6'. 1/2" CIR # 39074 not utilized in 'B6' in this survey.
