

- Quarter corner common to Sections 3 and 34. 1958: Billy D. Buckler, RLS. Rewitnessed iron pin with 2" top. Found witnesses: 12" J. Pine S73W 80½ links; R. Pine S63E 188½ links. Established 9" J. Pine N03W 27 links. No diameter given for Red Pine.
- Quarter corner common to Sections 3 and 10. 1958: Billy D. Buckler, RLS. Set 1" iron pipe with 4" brass cap witnessed by: 8" B. Spruce N72W 24 links; 12" J. Pine N63E 190 links. I-3.
 - East One-sixteenth corner of Section 3. Found 2" iron pipe set by landowner next to a hub. 9. Description of corner evidence found and/or method applied in restoring or reestablishing corner
- Found monument and W. Birch witness as described. Rewitnessed monument as found. 3-2.
- Found iron pin and witnesses as described. NW Jack Pine has blown over and SW Jack Pine is 1-1. dead but standing. Rewitnessed monument as found.
