Pipp, in a field survey on 1/10/2012AD do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

(POL) Point on East-West One-Quarter Line of Section 28. Not set in original survey, no evidence of subsequent establishment.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(POL) Point on East-West One-Quarter Line of Section 28, lying 13 feet East of the Top of Bank of the Cedar River and 24 feet from Waters edge. Position falls along an E-W Fence line and is 12 feet East of a Pipe driven in at an angle to anchor the end of the fence

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(POL) 1" Pipe with Plastic Cap
6" Red Pine N34E 10.51' (POL,BT)
13" Red Pine S65W 15.23' (POL,BT)
All trees are blazed, scribed, and painted. Measurements are to nail in side of tree, bearings are magnetic.
