

A. Description of original monument and accessories and/or subsequent restoration:

Original corner established by William A. Burt, U.S. Deputy Surveyor, 1847. Set Cedar Post.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

No original evidence was found. A 4"X4" yellow tag on an aspen indicating approximate corner 15 feet South. This position is East about 30 feet from the position I ultimately set the corner. I re-established the corner by single proportionate measure and on the Town line between the monumented SW Corner of Section 31 and the St Corner of Section 32. These two corners had been monumented from original bearing trees in 1961 & 1970 respectively. This position is consistent with a GLO call of "79 Chains Enter Swamp."

Research on file with the Ontonagon County Remonumentation Program Representative.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner.

At the corner position I set a  $2\frac{1}{2}$ "X30" split base aluminum pipe with a 3" cap stamped to read: County Remonumentation, T48N T47N R41W, S31, S32, S5, S6, P.S. 17610. I established three bearing trees and a reference object.
