A. Description of original m	onument and accessories and/or	subsequent restoration:	13

(D13) Standard Quarter corner on the south side of Section 32, on the 5th Correction line. 1845 - Established by Austin Burt, who set post. 14" Sugar N68E 31 links, 7" Sugar N47W 24 links. 1907-1910 Corner reestablished or remonumented by mining company surveyors W.B.Smith and/or Fesing and Gibbs. Shown on undated and unsigned survey drawing at offices of Steven Hein PS, Laurium MI. Bearings and distances to Section corners are given as N89 deg. 40'E 2639.50' to E13 and S89 deg. 56'W 2676.2' to C13. No description of monument. 1980 - K.L.Sackett RLS used a position midway and on line between Section corners to partially subdivide Section 32. Position was not monumented. 1997 - J.C.Domitrovich PS 37273 reestablished and monumented a position equidistant between Section corners and on the extension of a fence to west and distant centerline of Post Office Road to east. Set 5/8"x24" iron pin with bronze Ontonagon Co. Remonumentation cap. Corner falls 15 feet west of centerline of Post Office Road to North. 1997 position recorded in Liber 5 of LCR, Page 26.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(D13) Found the 1997 monument and record accessories in good condition. The Easting of the 1997 position, being a reestablishment of the Easting of the 1980 position, conflicts with the dimensions given on the old mining company survey. The mining company survey involves several sections and a retracement of a large part of the survey this date reveals that the measurements were well made and are reliable. I accepted the distances given on the mining company survey as the best available evidence of the position of the original corner and I reestablish the Easting of the corner position at the mining company distances to Section corners (prorated) N89 deg. 44'02"E 2639.47' to E13 and S89 deg. 49'13"W 2676.17' to C13 (True bearings), and the Northing of the corner at the extension of the old fence to the west, noted in the 1997 record. The position thus established falls at the approximate intersection of the extended centerlines of Post Office Road north and east. With the approval of Mr. Domitrovich, I removed the 1997 monument which I found S89 deg. 49'33"W (True brg.) 18.35' from the reestablished corner.
