Meander Corner on the north shore of Six Mile Lake between Section 36 T51N-R37W and Section 31 T51N-R36W. 1854 - Established by Wm.A.Burt Deputy Surveyor 6.82 ch. North of the position for M13 and 33.18 ch. South of M12. Set post. Tamarack 6" N75°E 79 links, Tamarack 6" N14°W 136 links. Witnesses following are numbered to correspond to those in Part B. 1957 - MSHD highway plans show 3/4" iron pipe at the corner with witnesses: 1) 12" Birch N25°W 25.42'; 2) 12" Pine stp. N15°E 23.55'; 3) 10" Oak S65°E 44.50'. 1979 - K.L.Sackett RLS records that he restored the corner position from the MSHD witnesses and set a 1"ID I.pipe with 4" alum. cap witnessed by: 4) 18" W.Pine N38°W 33.4'; 5) 23" W.Pine N89°E 70.4'; 6) Concrete ROW marker N07°E 12.2'. 1990 - R.Crampton RLS records that he found a 1" iron pin from MSHD notes, witnessed by nail and tag in: 7) 23" W.Pine N34°W 33.67'; 8) 9" W.Birch N50°E 33.62'; 9) 18" Oak S64°E 43.73'; 10) center of conc. B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found a 1" dia. iron pin set flush, in good condition, in accord with the witnesses of record referenced above: 1) a stump; 2) not found 3) in good condition. Set new witness nail in this 4) now standing dead with scribing "MC NBT" visible; 5) a stump; 6) measured tree (see below); 12.2' to south face and 12.35' to center; 7) same as 4); 8) now standing dead, about 25' tall with overgrowth covering tag; 9) same as 3)-overgrowth covers the 1990 witness tag; 10) same as 6). I note that the position of this monument is 30.923 chains (2040.91') south of corner M12 and it is likely not the original Meander Corner position but, rather, a witness corner to the MC. Based on record GLO distance to M12, the MC is 148.97' south of this position.
