I, Stephan J. Szyszkoski, in a field survey on 06/11/14 do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(12-Sec. 36) Center-South 1/16 corner, Section 36. Not previously monumented.

(M12) Quarter corner common to Sec. 36 T51N-R37W and Sec. 31 T51N-R36W. 1854 - Established by Wm.A.Burt Deputy Surveyor 33.18 ch. North of MC on north side of lake and 40.00 ch. South of Section corner. Set post. Birch 14" S65°W 36 links, Maple 16" N60°W 41 links. 1957 - MSHD highway plans show 1.5" iron pipe at corner and witnesses: S52°E 12" Maple 13.30'; N55°W 5" Maple 6.88'; S74°W 7" Maple 21.22'. 1990 - R.W.Crampton RLS found 1.5" iron pipe and set witness nails with tags in: 5" Cherry N12°W 31.44'; 5" Maple N89°E 30.91'; 22" Hemlock S88°E 32.35'; 5" Maple N84°W 29.58'

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(12-Sec. 36) Established the position for the corner midway and on a straight line between Quarter corner 1350.47' south and the Center of Section 36 1350.47' north.

(M12) The original post and accessories were not recovered. Found a 1.5" ID iron pipe, top bent over but below-ground portion still plumb and firm. The 1957 NBT Maple S74°W 21.22' was found at record bearing and distance, now a very low cut stump. The 1957 NBT Maple S52°E 13.30' is a rotted stump. But for the Hemlock S88°E 32.35' which was not found, the 1990 witnesses are in good condition and at record bearing and distance. The pipe is 40.068 chains S0°00'22"W (true bearing) from the monumented Section corner M11. I accepted the pipe as the best available evidence of the position of the original corner. Replaced it with a new monument, described below.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(12) Set 1"IDx28" I.pipe with 2" alum. MDNR cap. Set measuring nail with MDNR tag in the side of:
7" Oak N08°E 7.3' mrkd "1/16S BT"
5" Oak N85°E 1.9' do
5" Oak S20°E 5.55' do
4" R.Pine N26°W 26.5' do
Set sq'd Cedar post adjacent.

(M12) Set 1"IDx28" I.pipe with 2" alum. MDNR cap at the position of a found 1.5" ID iron pipe. Set measuring nail with MDNR tag in the side of:
5" Sugar N31°E 11.45' mrkd "1/4S NBT"
5" Y.Birch N79°E 8.55' do
4" Y.Birch S60°W 3.2' do
4" Sugar N40°W 20.0' do
Set sq'd Cedar post adjacent.
