I, Joseph C. Domitrovich, in a field survey on June 14, 2000, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

(M - 13) Township Corner, Section 36, T52N R39W, Section 31, T52N R38W, Section 1, T51N R38W, and Section 6, T51N R39W.

1845 - William A. Burt intersected Range line 46 links South of temporary post and set post, corner of Township 52 & 51 North & Range 38 & 39 West.

14" Maple N 27°E 25 links  
 12" Sugar S 67°W 21 links

1956 - Ned Hawley, Timber cruiser, noted in his copy of the original notes and in a note on loose paper in the field book that he found a cedar stake at the corner. He noted that the cedar stake fell at the top of hill to river, north of slight draw. He made a note to verify that both B.T.'s were maple but does not indicate if he did find original B.T.s.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I found no remains of the original corner. I found the rotten remains of the cedar post (stake) called for by Hawley. A shallow depression with remains of unidentified rotten wood corresponds with where the 14" Maple B.T. would fall. The post falls at the west top of ravine, 8' +/- north of a shallow feeder ravine as called for by Hawley. Distances to section corners East, West and North work well with GLO. I have accepted the position of the cedar post as the township corner.

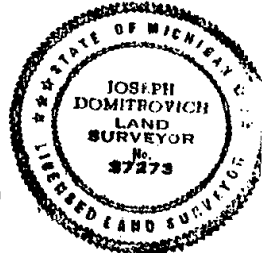

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner is a 2 1/2" x 30" aluminum pipe with a 3" diameter aluminum cap stamped to read: COUNTY REMONUMENTATION; T52N, T51N, R39W, R38W; S. 36, S. 31, S. 6, S. 1; 2000; P.S. 37273. Corner falls on Northerly edge of power line clearing. Ties:
