- A. Description of original monument and accessories and/or subsequent restoration:
- J1 1838 Post set for one-quarter section corner in original government survey by John Brink. Deputy Surveyor, Comer Witnessed by: (1) Hemlock 11" N221/2°W 40 links; (2) Beech 16" N62°E 24 links
 - 1937 Misc. DNR notes of survey line run along North Line of Townships T24N, R11 & 10W. The names F. L. VanSickle, Rathburn & F. Clark appear on various pages of the notes. The survey lines may have been assisted by CCC crews. It appears M. Schaaf used this survey line to search for corner evidence in the 1940's - "set post 40.00 ch. E. of Random post near NW cor. of Section 2, T24N, R11W."

 - This corner was established by single proportion method between section corners. Corner positions at 'I-13' and 'K-13' as monumented by Roser were not accepted by the Peer Review Group. 'J-13' was re-established by single proportion method between the accepted section corners (see remon. LCRC for section corners) and monumented by a 2 1/2" by 30" flared bottom galvanized iron pipe with a 3 1/2" brass cap stamped GRAND TRAVERSE COUNTY REMONUMENTATION. Schaff witnesses sites, utilizing the witnesses excavated Schaff site but did not recover any evidence of monument. Set 60d spike from witnesses for reference. The section corners East and West are both Schaff positions accepted by the Peer review group in 2008 and 2010. This Schaff quarter corner position is significantly north of a straight line between his corners East and West (44.63'). As the GLO witnesses were Hemlock and Beech and not very fire resistant, it is unlikely that Schaff recovered the GLO sites so far north of line between section corners. Considered corner Lost and moved existing county monument (21/2" by 30" steel pipe with a 31/4" Brass cap) to position of midway and on line between accepted section corners east and west and is considered a careful and faithful re-establishment of the GLO corner location. 2½" by 30" flared bottom steel pipe with a 3½" Brass Cap
