- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- K11 Section Corner common to Sections 25, 26, 35, & 36, T24N, R11W Found remains of Schaaf's witnesses #3 and 6. Position falls on north edge of cleared east- west 2-track. Dug here but no evidence of a Schaaf monument was found. Schaaf notes that he had GLO corner tree site and line tree to the east. Thus set stamped 4" Department of Natural Resources (DNR) Aluminum Cap on 1" x 36" long galvanized iron pipe at Schaaf's position. Centerline of east-west 2- track is 15' south. Centerline of northsouth 2-track is 78' west. Condition of witnesses as follows: #1, 2, 7, 8, 9 & 10-Rejected Fargo position; #3- S2°22'W (geodetic) 63.7' to set spike in centerline remains 24" white pine stump (This also being Fargo's witness #2); #6 -S79°07'W 100.8' to set spike in centerline Oak stump; Witnesses #4 and 5 are gone. Fits tie to Fargo position closely. DNR monument accepted as a careful and faithful perpetuation of the position of the original corner.
  - -Reference Point -S47°09'52'W (Grid) 47.24' from 'K11' to found Department of Conservation (DOC) Monument with Fargo pipe alongside per Roser at Fargo Engineering proportional position. Could not accept Fargo's proportional position over Schaaf's original recovery. DOC monument not utilized as 'K11' in this survey. Removed 4" DOC Aluminum Cap on 1" x 36" long iron pipe. Reset Fargo's ¾" x 30" long iron pipe with hooked end in its place. Also left a couple of found pieces of broken butter dish at its

- K11 Stamped DNR Aluminum Cap on 1" x 36" long galvanized iron pipe with 4" x 1' long PVC pipe with concrete around the cap- 0.7' below grade.

Add Blue Carsonite Post with location tag 15' north. N38°W 44.30' to set nail and tag(N&T) in NE. side 12" Oak scribed 'XBT' N12°W 35.31' to set N&T in W. side 10" Red Pine -found with blazes N57°E 18.23' to set N&T in NW. side 14" White Pine scribed 'XBT' S19°W 68.69' to set N&T in E. side 15" White Pine scribed 'XBT S47°09'52"W 47.24' to Reference Point- 3/4" iron pipe
