J1 – Standard ¼ Corner common to Section 2, T24N, R11W & Section 35, T25N, R11W – Found 3 ¼" Brass Cap Monument that was reset by R. F. Mitchell in November of 2010 per LCRC 2011L-00086. Monument was set by single proportion between remonumented Marcus Schaaf positions at 'l-1' & 'K-1'. No GLO evidence. Measured grid bearing and distance of S89°40'20"E 2627.14' (2640' – GLO) to 'K1' and N89°39'55"W 2626.64' (2640' – GLO) to 'l-1'. Grand Traverse Co. Monument accepted as a careful and faithful reestablishment of the position of the original corner.

- -Reference Pt. 'D' Fd. 3 stump remains and living R. Maple tree per 1942 M. Schaaf notes. R. F. Mitchell dug at this position but didn't find stake. He set 60d nail per witnesses. This nail is N12°16′E 44.63′ from 'J1'. This Schaaf position is closely on Schaaf's line of monumentation from the East extended Westerly. Accepted Schaaf's position to 'K1' but rejected his positions at 'L1'and 'M1'. Thus felt his line of survey was questionable. When M. Schaaf references sites he is believed to be talking about possible stump hole evidence. This position was established by Schaaf before he recovered position at 'l-1', has questionable site evidence and is too far north to be acceptable in this surveyor's opinion. Schaaf position not utilized as 'J1' in this survey.
- Reference Pt. 'E' Fd. 4" x 30" Wexford County Alum. Mon. per C. F. Roser 1974 LCRC is S22°21'E 27.69' from 'J1'. This position is based on single proportion between rejected corner positions at 'I-1' and 'K-1'. Wexford Co. Monument not utilized as 'J1' in this survey. Replaced Wexford Co. Alum. Mon. with '½" x 24" rebar.
- Reference Pt. 'F' S15°35'E 6.06' of 'J1' is position per LCRC 2008L-00014. Position is based on single proportion position between 'K1' and rejected position at 'I-1'. Rejected this position and R. F. Mitchell removed the Grand Traverse Co. Monument.
